The undersigned hereby acknowledges that the creditor (hereinafter sometimes "Vendor") is relying on this information to extend credit and authorizes the Vendor to make inquiry into, to request, and to receive any information concerning the credit and general reputation of the Applicant and all information from creditors which the creditor deems relevant for the granting and collection of the proposed borrowing. This authorization shall be effective from the date upon which this application is signed and it shall be continuing so long as credit is extended. Upon written request from Vendor, additional information within the scope of this inquiry will be timely provided.
